Release, Waiver of Claims, Assumption of Risks and Indemnity Agreement

BY SIGNING THIS DOCUMENT YOU WILL BE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE

I, the undersigned, desire to engage in activities involving firearms with Villages Straight Shooters Inc. ("VSS"), a Florida Not-For-Profit Corporation and, in consideration of being allowed to engage in such activities with VSS, I, on my own behalf and on behalf of my heirs, representatives, administrators, successors and assigns (hereinafter referred to as "Releasers"), hereby promise, covenant, represent and agree, in accordance with this Release, Waiver of Claims, Assumption of Risks and Indemnity Agreement ("Agreement") as follows:

1. Assumption of Risks. I UNDERSTAND THAT FIREARMS, SHOOTING, AND ITS RELATED ACTIVITIES ARE INHERENTLY HAZARDOUS AND INVOLVE BOTH KNOWN AND UNANTICIPATED RISKS, INCLUDING BUT NOT LIMITED TO THE FOLLOWING:

- A. Suffering grievous bodily and/or emotional injury to myself and/or other persons;
- B. Damage to property;
- C. Paralysis;
- D. Death;
- E. Being shot by someone else or shooting myself;
- F. Accidental, intentional or negligent physical injury caused by others;
- G. Partial or total loss of eyesight or hearing;
- H. Inhalation or other harmful contact with lead or other contaminants;
- I. Being struck by flying or falling objects;
- J. Ricochets from targets or projectiles;
- K. Injury to property or person as a result of negligence by VSS, or any of its members; and,
- L. Inclement weather conditions and animals or insects found in the wild.

I understand that such risks cannot be eliminated without compromising the essential qualities of firearms related activities and I hereby elect to voluntarily participate and engage in such activities knowing they are hazardous and/or dangerous to me, others, and my property.

I freely accept and fully assume all risks, danger, and hazards and the possibility of personal injury, death, property damage or loss, resulting therefrom. I also understand that VSS makes no representations, warranties or other assurances with respect to the quality or safety of its firearm activities.

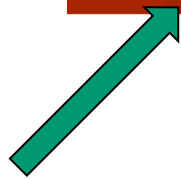

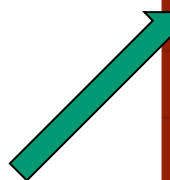

From time to time members have a need to utilize an FFL dealer to transfer firearms from an online purchase or from one location to another. Most all entities that have an FFL (Federal Firearms License) will, and are authorized legally, to handle firearms transfers and purchases including the required background checks.

Prices vary and can range up to \$60 per gun. The least expensive option is listed below for your information. Quite a few Straight Shooters have already used his service. He charges \$25 per firearm transfer (**EFFECTIVE 01/01/23**) which includes the background check. **Call first before placing an order.**

The way it works is the buyer contacts Jeff via email with the following info: Buyer's name and address, phone number, CWFL yes or no, and who they are purchasing or transferring the weapon from including the company's email address. If he is not already on file with them he will send them a copy of his FFL.

When the gun comes in Jeff will log it (or them) in and call the person to arrange a time for pick-up.

Jeff has transferred over 2,500 firearms with over 90 percent for residents of The Villages. Most of his customers have made multiple transfers.

If you are a Villages seasonal resident and wish to transfer firearms to or from your home away from the Villages, Jeff can handle the transfer(s). If you are transferring firearms into the state, a background check is still required. To transfer firearms out of state, either you or Jeff can do the packaging, however, he must first see the firearm(s) to verify the serial numbers.

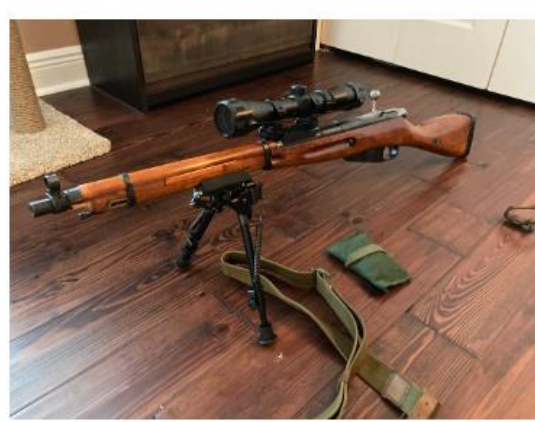

Castle Do

The Florida "Castle Doctrine" law basically does three things:

One: It establishes, in law, the presumption that a criminal who forcibly enters a home or occupied vehicle is there to cause death or great bodily harm, therefore a person may use any manner of force, including deadly force, against that person.

Two: It removes the "duty to retreat" if you are attacked in any place you have a right to be. You no longer have to turn your back on a criminal and try to run when attacked. Instead, you may stand your ground and fight back, meeting force with force, including deadly force, if you reasonably believe it is necessary to prevent death or great bodily harm to yourself or others. [This is an American right repeatedly recognized in [Supreme Court gun cases](#).]

Three: It provides that persons using force authorized by law shall not be [prosecuted for using such force](#).

It also prohibits criminals and their families from suing victims for injuring or killing the criminals who have attacked them.

In short, it gives rights back to law-abiding people and forces judges and prosecutors who are prone to coddling criminals to instead focus on protecting victims.

ACCURATE AMMO FOR SPECIFIC FIREARMS

As of Dec. 21, 2022

These are the results of tests by gun writers from 6 different gun mags beginning in 2018. They are based upon a limited selection of ammo chosen by the writers and are in no way a comprehensive result. However, it should point you to ammo that has performed at the top of these groups and prove a solid choice for a particular firearm. These tests only involve accuracy, and the selected ammo may not be best for all purposes. As an example, take the case of the Springfield Armory XDM in 10 mm: Although the featured ammo, Barnes VOR-TX 155 Gr. XPB is, indeed, the best choice for target work and plinking, Hornady Critical Duty 175 Gr. FlexLock is better for self-defense for a number of reasons. But, judging on accuracy alone, it proved the “worst” load of the group. HSM BEAR Load 200 Gr. RNFP was the best choice for hunting medium size game, etc. So, it's important to know for what purpose a particular ammunition is going to be used.

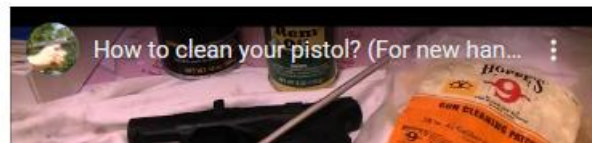

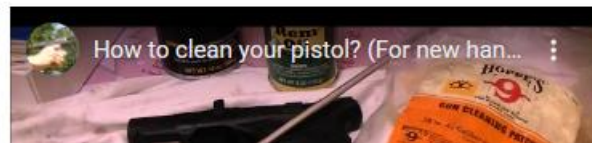

Concealed Weapon and Firearm License

Obtaining a Florida Concealed Weapon and Firearm License enables you to carry a firearm in the state of Florida. A Florida permit is also recognized in many other states through reciprocity. Florida is a "shall-issue" state. The state has no discretion in awarding the permit and may not discriminate, provided you meet the requirements as specified in the law. To be eligible to receive a permit, you must meet the minimum age, legal and resident requirements, complete an application and have your picture and fingerprints on file.

Eligibility To obtain a CW permit in Florida, you must be at least 21 years of age and must demonstrate competency with a firearm. To qualify you must complete a state-approved course involving the safe use of firearms. See the "Education" tab for more information on classes. An applicant must be a United States citizen or permanent resident alien. Residency may be proved with a document such as a bank or credit card statement, utility bill or other appropriate document that shows your name and a Florida address.

Disqualifications A convicted felon cannot obtain a CW permit unless your civil firearm rights have been restored by the court. Conviction of a misdemeanor involving violence within the past three years, also disqualifies you from possessing a CW permit. Two or more DUI convictions in the past three years or a confirmed record of substance abuse also precludes you from obtaining a CW permit. Individuals who have been dishonorably discharged from the U.S. military or have renounced their U.S. citizenship are not be eligible.

Permit Details Since 2008, a Florida concealed weapons permit is valid for seven years and can be renewed within six months of its expiration. If allowed to expire, you must reapply and execute the steps that are in effect at that time. A concealed weapon permit allows you to carry in the state of Florida, as well as other reciprocal states. Currently Florida has the second widest reciprocity following Missouri. According to the law, you must not be in possession of a concealed weapon at a police station, courthouse, school or at the airport.

Concealed Weapon License Reciprocity

[Section 790.015, Florida Statutes](#), allows Florida to recognize concealed weapon licenses issued by other states if the other state agrees to recognize Florida concealed weapon licenses.

Eye Protection

What You Should Look For In Eye Protection

Non-ballistic eye protection is fine for keeping relatively slow-moving objects away from your face. Empty cases ejected from a firearm, dirt kicked up by muzzle blast, etc. For faster-moving projectiles such as ricocheted bullets, you need high quality, tested eye protection. I would personally prefer eyewear with a single piece lens for any activity where my face might be struck by small, fast-moving objects.

Individual lenses detach from the frames once a certain level of force is reached, and they are driven back into the eye sockets - sometimes at undesirable angles - where considerable damage may be done. There are good two piece lens eye protection out there, like the Smith Optics Director, but single-piece lenses distribute force much better.

Also, a wide, comfortable, and preferably soft rubber nose-piece is critical. This will, along with good "arms," serve to keep the eye protection in place during energetic activity - but it will also reduce the chances of the lens being driven down or back into the face at angles or with enough force to damage the orbital bones.

A frame that connects across the top of the lens, not individual arms which attach to the outside corners of the lens, is recommended. This will reduce the chances of the lens detaching from the frame - it's still possible, just less likely - under impact. Depending on the design, some eye wear with this design does not

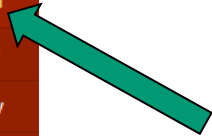

Ear Protection

Select Proper Hearing Protection for Shooting to Avoid Permanent Hearing Loss

When working around loud industrial plant noises, individuals can experience terrible ear pain, continuous ringing in their ears, and substantial hearing loss from job-related noises. Also, from regularly shooting firearms, serious hearing problems can develop quickly.

Sometimes new shooters don't pay as much attention as they should to protecting their hearing. Forgoing quality hearing protection for just one time... or focusing only on eye protection can be a big mistake. You should consider both eye and ear protection important and mandatory for shooting. Virtually all ranges require "eyes & ears" before entering the range area.

Noise Hazard from Shooting

The noise from gunfire is one of the most hazardous non-occupational noises that people are exposed to. It's possible that a single gunshot heard by an unprotected ear can lead to immediate and permanent hearing loss, often accompanied by tinnitus or ringing, hissing or humming in the ears.

The Cleveland Clinic and the Sight and Hearing Association report that hearing loss can definitely result from a single gunshot or from noise over an extended time. According to Dr. William Clark, senior research scientist of the Noise Laboratory at the Central Institute for the Deaf in St. Louis, "the damage caused by one shot from a .357 magnum pistol, which can expose a shooter to 165 dB for 2msec. is equivalent to over 40 hours in a noisy workplace." Dr.

When a member is at a gun range while engaged in a club sponsored event, the following range rules and etiquette must be observed including the rules for that specific range. Failure to do so may result in the Range Safety Officer asking the member to leave the range.

REMEMBER

1. **Always** keep your gun pointed in a safe direction.
2. **Always** keep your finger off the trigger until ready to shoot.
3. **Always** keep your gun unloaded until ready to use.

When arriving at the range:

- All guns must be unloaded and cased
- A concealed carry firearm is prohibited
- Guns may only be uncased or cased at the firing line during a hot range
- Uncased guns may NOT be transported to or from the ready line to the firing line
- Eye and Ear protection must be worn at all times
- Targets shall be mounted at eye level so you are NOT shooting into the floor or ceiling down range

When at the firing line:

- Obey all Range Safety Officer commands promptly
- When the range is cold, stay behind the "Red" line & DO NOT handle any uncased gun
- During a cold range or when you are not actively shooting, all guns at the firing line must be unloaded, pointed downrange, action open and up for observation by RSO

Shooting Hygiene

Any amount of lead exposure is harmful to human health. People using firearms, handling ammunition or visiting shooting ranges are at risk of inhaling or swallowing lead, or to a lesser extent, absorbing lead through the skin.

How are we exposed to lead? Lead is present in most types of ammunition. It can be found in the projectile and the primer (the explosive that ignites gunpowder) of ammunition.

Lead in the primer and the outer surface of the projectile is vaporized and released into the air after a firearm is discharged.

Lead dust and fragments are also released when the projectile impacts solid surfaces.

For these reasons, surfaces in shooting ranges may be contaminated with fine lead dust. This dust can also be breathed in and swallowed.

Lead dust may be suspended in the air or stick to people's hands, hair, face, clothing and footwear. This dust may be transported on your body, clothing and equipment from a shooting range into a car and into your home.



D-Lead removes lead and other heavy metals from your skin and other surfaces. D-Wipe Towels are convenient one-use wipes that are portable and can be used on the bench or at the range. D-Lead Dry or Wet Skin Cleaner cleans and conditions the skin with or without water.

How can I reduce lead exposure?

Choice of ammunition

In the past, lead-based ammunition has been used because of its high density, lower cost and longer shelf life. However, alternatives to lead ammunition are available.
