



 After a "personal defense" incident occurs, how does the legal system determine if you acted in self defense?

Sample Scenario

- You are legally carrying a concealed firearm.
- You are verbally threatened. The attacker pulls a large knife and moves towards you aggressively.
- You "fear for your life or great bodily harm."
- You are able to draw your gun and shoot.

- What are the first steps?
 - DO NOT LEAVE THE SCENE!
 - Put the gun away hands empty
 - The police & EMTs are called and arrive.
 - "Attacker" declared dead at the scene
 - "Attacker" is now the "Victim"

Next Steps

- You will be disarmed & handcuffed while police begin the investigation. Mirandized.
- What should you say to the police?
 - Brief statement of Facts. NO emotion.
 - Point out evidence that might be overlooked

• Next Steps

- Request attorney before formal questioning. making a written or taped statement.
 - ID Attorney NOW, keep number with you.
- What are the issues the investigation will assess to determine if you acted in self defense ?

- Self Defense Criteria
 - Innocence
 - Imminence
 - Proportionality
 - Avoidance
 - Reasonableness

Innocence



- Innocent of being the "aggressor"
 - Didn't start, forcible sustain, or escalate the confrontation
- Aggressor's actions must be "provocative"

Innocence

Provocative Act

"An affirmative, unlawful act reasonably calculated to produce an affray foreboding injurious or fatal consequences"

Examples

- Words alone Yes
- Words + Slight physical contact – Yes
- Physical force only Yes

Innocence

- Sustaining the Confrontation
- Mutual Combat
- Escalation

- **Regaining Innocence**
 - 1. You must stop the conflict
 - 2. You must withdraw
 - 3. You must effectively communicate that you are withdrawing

Imminence

- An attack is "Imminent" if it is about to occur so quickly that it can't be avoided in any other way than with force.
- Moral Justification: <u>Necessity</u>
- Must be within the "Imminence Window"

Imminence

The AOJ Triad

- Ability
- Opportunity
- Jeopardy

- Ability
 - Is attacker able to hurt you?
 - Is attacker armed?
 - Are there multiple attackers?

Imminence

Opportunity

- Can the attacker get to me?
- Is he armed with a gun or a contact weapon?
- Can you avoid or escape?

Jeopardy

- Is there an indication of intention?
- Does not have to be announced
- Does the attacker stop or back off when warned?

Proportionality

- The force used in self defense cannot be greater than the force used to threaten you.
- You cannot meet non-deadly force with deadly force.
 - There are exceptions: Kidnapping, Aggravated Assault, Rape, Attack in your Home...

Proportionality

- Deadly Force
 - Projectile Weapons
 - "Contact" weapons
 - Knife, Club, Baseball Bat...
 - Other weapons based on how they are used

- **Non-Deadly Force**
 - Most likely scenario
 - Continuum of force
 - Verbal commands
 - Non-lethal weapon
- **Duration of Force**
 - Stop when threat stops

Avoidance

Duty to Retreat

- 17 States
- Retreat is <u>Required</u> before using deadly force
 - Exceptions: Not Safe, Make Worse, Protecting Another

- **Stand Your Ground**
- **33 States**
- Applies only in legitimate self defense
 - May fail reasonableness test
 - Where you have a right to be

Avoidance

Castle Doctrine

- Intrusion portends use of deadly force
- Removes duty to retreat
- Homeowner using force shall not be prosecuted
- Prevents civil cases by criminal's survivors

Other Factors

- Includes auto & place of business, other locations "where you have a right to be"
- Must meet other hurtles
 - Not be aggressor

Avoidance

 <u>Avoidance</u>, in practical application, refers to taking advantage of a safe avenue of retreat before resorting to the use of force against an attacker.

Reasonableness

- Umbrella principle overlaying the rest.
- Requires that everything you think, say, and do in self defense be reasonable.
- Defendant has "Presumption of Reasonableness"

Reasonableness

- Objective Reasonableness
 - Did you, under the circumstances, do what "Reasonable Ralph" would have done?
- Subjective Reasonableness
 - You must <u>actually</u> believe what you did was reasonable given the circumstances.

After the Fact

- Consciousness of Guilt
 - A guilty person acts differently than an innocent person.
- Consciousness of Innocence
 - You report the incident, you cooperate, you're not aggressive, positive reputation

So, what's the Verdict?

- Met all of the "hurtles" ? = Self Defense
 - You walk!
- *Fail any one* of the 5 hurtles Indicted!
 - May <u>not</u> be able to claim Self Defense
 - Breakout the checkbook, savings, IRA, ...
 - Craft a Legally Sound Strategy

So, what's the Verdict?

• If Indicted you could be charged with:

- Homicide
- Voluntary Manslaughter
- Involuntary Manslaughter
- Aggravated Assault
- Battery
- Brandishing

The Cost of Self Defense

- Retainer (\$5,000 \$25,000)
- Bond (if given)
- Attorney Fees (Hundreds of Thousands)
- Expert Witnesses, Private Investigators
- Appeals
