## NRA Training Terms and Conditions

---

The Villages Straight Shooters offers a selection of NRA training courses for its members. The training courses are conducted by club members that are NRA Certified Instructors who are fully qualified by training and experience to teach the particular courses they teach.

1. Course fees are established by the club to cover all expenses associated with offering the particular course. Fees cover NRA course materials, room rental, outside speakers, classroom incidentals, teaching aids, and other miscellaneous expenses. Fees established by the club are substantially less than fees charged for commercially offered training programs.
2. In addition to course fees, the student is responsible for range fees, gun rental if required, ammunition, and any other incidental fees not directly associated with the classroom course such as NRA filing fees when necessary and state fees for CWFL applications.
3. To participate in a course, each student must review, approve, and sign Release forms for the Gun Range, if used as part of the course, the instructors, and these Terms and Conditions. If an individual chooses not to sign the Release forms, he/she may not participate in the training program and any course fee paid will be refunded less any costs already incurred for training materials and venue.
4. All courses taught by club instructors are taught in compliance with the established NRA defined curriculum and lesson plans without modification of any consequence.
5. Class fees must be paid a minimum of two weeks before the start of the class so that course materials may be ordered and other up front expenses handled.
6. Refunds will be offered if the individual cancels attendance 7 or more days prior to the class in writing or confirmed email. If a cancellation is requested within 7 days prior to the start of the class, a 50% refund will be given. If the cancellation is received within 24 hours of the start of the class, or the individual must leave the class before completion of all class course material, no refund will be offered.
7. If a student intentionally does not follow the range safety rules, the directions of the Range Safety Officer, or is disruptive or disrespectful to the conduct of the class, instructors or other students, at the sole discretion of the Lead Instructor, the individual may be ask to leave the class. In such a situation, no refund will be offered. The individual may not be permitted to attend other classes conducted by, or on behalf of, the Villages Straight Shooters club.
8. NRA Completion Certificates are awarded to students at the sole discretion of the Instructor based of the student's ability to complete the course requirements as defined by the NRA. A student may be provided the opportunity to satisfactorily complete the class requirements subsequent to the end of the class at the instructor's discretion. A student that does not fulfill the course requirements will not be given a refund of the course fees.
9. Prior to the beginning of a course, the student will be advised of the course prerequisites, if any, and must demonstrate to the Instructor's satisfaction that they, in fact, meet the requirements.
10. If the student has any special requirements or handicaps that must be considered, the prospective student must advise the Instructor at the time of enrollment in the course to ensure the needs can be met.
11. Each course taught, according to NRA guidelines, must have a minimum of 4 students enrolled. If an individual enrolls in a course that is subsequently canceled due to lack of enrollees or for any other reason, any fees paid will be refunded or may be rolled over to the next available scheduled course at the discretion of the prospective student.
