This can be fixed by electing strong anti-crime politicians that will enforce good laws and fund law enforcement along with legislating new laws that protect the law-abiding citizens.


Majority of Voter Households Own Firearms

Ouestion 1:

I see advertisements in magazines, such as *American Rifleman*, for suppressors.

For the State of Florida, what laws / restrictions / requirements apply to the purchase and use of suppressors?

Answer:

Florida law does not impose any more restrictions than the National Firearms Act (obtain a tax stamp, ATF background check, etc). A great source for NFA can be found on ATF's website at:

Ouestion 2:

My father in Ohio died and left me all his guns in his will. Can I legally just take them home with me.

Answer:

The executor of the will can transfer the firearms directly to the member (as long as Ohio laws allows

it). Because this is an inheritance and not a gift or purchase, the member is not required to go through an FFL to bring the firearm back to Florida. Here is a link to an article we wrote on our website regarding inheriting a firearm:

Is there a single source I can check to see if a gun I am planning to buy via private sale has been stolen?

Answer:

FDLE has a page on their website that allows a person to check:

This is probably the best website for a citizen to check whether or not a gun has been reported stolen.

Lock the gun in place with a better grip and more predictable trigger placement, every time.

"WEAVER Vs. ISOSCELES!"

With a few exceptions, there are basically two stances you could choose from when firing a handgun. And, except when injuries or physical limitations are dictating the equation, it all depends upon the individual and what they're comfortable with. Let's take a look at both:

ISOSCELES:

A great starting point for any shooter using a handgun, it is aggressive but relatively easy to assume and, barring those pesky age-related hiccups, it allows the shooter to naturally point at the target.

On the negative side, some shooters tend to overdo the elbow locking thing and actually lessen the side strength pressure they need to help tame recoil. In addition, there can be some front to rear balance problems. This is the position that most of our instructors will suggest a new shooter begin.



WEAVER:

With the strong side leg drawn back (not too far please), this proves more comfortable for some. It also gives you an opportunity to apply the push-pull method of securing the firearm. The support arm

elbow does require a bit of bending. You might know the name of Col. Jeff Cooper, an innovator in modern pistol shooting, who tended to take the elbow-bend to the extreme and – to me – it just looked a bit strange.



A Modified Weaver stance, with the strong-side leg drawn a little forward, closer to the support leg, is also very popular. One advantage to either Weaver stance is that more side pressure can be applied to the firearm, providing improved recoil control. On the negative side, shooters tend to tilt their heads a bit when applying this stance and should be careful not to overdo it, which might throw off their sight picture.

Although I personally prefer the Modified Weaver stance, I admit to switching back to the Isosceles when I feel like I'm not concentrating enough. For some reason, it helps me bear down on the target. So why not use it all the time? Who knows?! I'm comfortable with both

Try both (or something in between) and see how they feel. Ask an instructor to evaluate your stance. You'll



eventually settle into your comfort zone and will hopefully improve your marksmanship.
